

## **ATTACHMENT B**

#### STUDENT REPRESENTATIVE

### Art. 1 - Student Committee

- 1. A Student Committee will be instituted with the aim of strengthening and stabilizing the interpersonal relations and for instituting a place of comparison and listen.
- 2. The duties of the Student Committee are:
  - To formulate proposals for improving the conditions of the assignees in the university residences through the presentation of specific documents and queries.
  - To produce an annual report on the state of the assignees services and conditions to be presented to the Opera BoD (Board of directors), also on the basis of statistical surveys on the students satisfaction required by the Committee or directly promoted by the Opera Universitaria BoD and with the possibility to access, under the current legislations, to the documents necessary for developing its own activity.
  - To encourage cultural, sports and recreational activities to be performed in the common areas in compliance with the Art. 3.

#### Art. 2 - Creation of the Student Committee

- 1. The students beneficiary of accommodation can submit the candidacy within 7 days before the elections at one of the help desks organized by Opera Universitaria. The candidate list will be published online on www.operauni.tn.it and on paper. This last can be consulted at the Reception of Studentato S. Bartolameo and Collegio di Merito.
- 2. The right to vote and stand is guaranteed to all the students beneficiary of accommodation. The loss of such requisite implicates the deprivation of the right to vote and/or to stand as a candidate. The forfeiture is decided by the students delegates in the Board of Directors.
- 3. In the respect of the diversities and differences of location of the numbers of residences, the elections will take place in four days. The student committee will consist of the following delegates, chosen per area of location:

San Bartolameo: 4 delegates
Trento city center: 2 delegates
Collegio di Merito: 1 delegate

Caproni: 1 delegatePovo: 1 delegateRovereto: 1 delegate

- 4. Within October, the 20th of each year, the delegates of the students in the Board of Directors usually announce the elections for the delegates of the Students Committee, if not differently decided with an adequate motivation.
- 5. The elections take place with individual candidacies. The candidates with the biggest number of preferences will be elected within the depletion of positions.
- 6. The student can express a maximum of two preferences, if only from different genders.

# Art.3 - Use of the common spaces

- 1. All the common spaces in the residences can be made available by the Students Committee for recreational, cultural and educational activities during the working time of the Reception and not further 12.00 p.m. These activities must have the authorization of Opera Universitaria, considering the motivations, the respect of the security rules and this regulation itself, also with the possible definition of limits and particular regulations, that will be observed with great care.
- 2. The promoters of the initiatives will present the written and justified request. in case of authorization, it could be provided a cautionary deposit of a variable cost, decided case by case, with the assumption of responsibility also of the potential damages caused by the participants. The cautionary deposit will be given back after the check of the absence of damages. On the contrary will be held for a partial or total coverage of the damages.
