**THE ACCOMMODATION CONTROL STAFF CAN TAKE
PHOTOGRAPHS TO TESTIMONY THE STATE OF THE
ACCOMMODATION, WHICH YOU CAN SEE IF REQUESTED**


PLEASE NOTE

IN THE EVENT OF A **PROLONGED ABSENCE (MORE THAN 15 DAYS), YOU MUST NOTIFY THE ACCOMMODATION CONTROL IN WRITING, STATING THE ESTIMATED DATE OF YOUR RETURN.**

HOWEVER, THE ACCOMMODATION WILL BE CHECKED AND THE ABSENCE WILL BE TAKEN INTO ACCOUNT (E.G. DUST ON FURNITURE WILL NOT BE REPORTED).

REMEMBER THAT THE ACCOMMODATION, EVEN IN THE EVENT OF YOUR ABSENCE, MUST BE LEFT CLEAN

SWEEP AND MOP THE **FLOOR**

CLEAN THE **HOB** AFTER EACH USE

WASH THE **DISHES** AFTER EATING AND TIDY THE COMMON AREAS

BE CAREFUL WHEN CLEANING THE **FRIDGE** AND **FREEZER**, MAKE SURE TO FOLLOW THE INSTRUCTIONS PROVIDED BY OPERA

CLEAN THE **MICROWAVE OVEN**

HOW TO CLEAN YOUR ROOM TO AVOID FINES

SWEEP AND MOP THE **FLOOR**: THERE MUST BE NO WADS OF DUST AND CRUMBS OF VARIOUS KINDS

REMOVE CRUMBS AND DUST FROM **FURNITURE**

DO NOT KEEP **FRESH FOOD** IN THE ROOM OR IN ANY CASE FOODS THAT, IF STORED IN A NON-OPTIMAL WAY, COULD ATTRACT ANTS OR INSECTS

DIFFERENTIATE THE WASTE CORRECTLY, USING THE BOXES THAT HAVE BEEN PROVIDED TO YOU.

IF YOU DO NOT HAVE ONE, ASK FOR THEM VIA SEGNALAGUASTO

HOW TO CLEAN THE BATHROOM TO AVOID FINES

CLEAN THE **SANITARY WARE**, USING THE APPROPRIATE PRODUCTS TO REMOVE LIMESCALE

BE CAREFUL OF THE **SHOWER TRAY** AND **SHOWER DOORS**

SWEEP AND MOP THE **FLOOR**

IN CASE OF PRESENCE OF **MOLD**, CONTACT THE STAFF VIA **SEGNALAGUASTO**
