The call for application was designed in accordance with the main accessibility guidelines.



1. RECIPIENTS

This call for applications is intended for students who are under 35 years of age on January 1st 2026, who are citizens of European Union countries, Iceland, Norway, Liechtenstein, San Marino, Switzerland, and Vatican City and for students who are resident in Italy but are citizens of non-EU countries:

- who enroll at the University of Trento for the first year or subsequent years in the following courses:
 - Bachelor's Degrees (Under graduate degrees)
 - Master's degrees
 - Five and Six-year Master's Degree
 - PhD programs, provided they do not benefit from other scholarships or other kinds of funds for the PhD program, and are not on a paid leave of absence
- who enroll at the Conservatory of Music or another University Institute of Trento for the first year or subsequent years in the following programs:
 - Bachelor's degree from the Advanced School for Linguistic Mediators in Trento (SSML) and from the "Trentino Art Academy" Advanced Art Institute and undergraduate degree from the Conservatory of Music of Trento "F.A. Bonporti"
 - Master's degree from the Conservatory of Music of Trento "F.A. Bonporti"
- who intend to transfer to the University of Trento, the Conservatory of Music or another Higher Education Institute in Trento from another University or Institute.

In case of simultaneous enrollment in two degree programs for the a.y. 2026-2027, students who are already enrolled in years subsequent to the first and have already received student welfare benefits cannot use the second enrollment as a reference to obtain the same benefits. Students may request the aforementioned benefits for their second course of study only if they have never previously received or applied for them.

PLEASE NOTE

Application for benefits must be submitted regardless of actual enrollment for the a.y. 2026-2027, as university enrollment deadlines may fall after the deadline for this application. Students must apply even if they do not yet know the results of their admission test or have not yet enrolled for their chosen program. For example, students who are not yet enrolled in a Master's degree program by September 7th, 2026, must still submit their application for benefits within the deadlines set out in [section 10.2](#) of this Call).



SINGLE-CYCLE MASTER'S DEGREE IN MEDICINE AND SURGERY

Students enrolling for the "selection semester" ("semestre filtro") at the University of Trento, according to the provisions of Legislative Decree no. 71/2025, must submit the application for benefits by the deadlines indicated in [section 10.2](#).

For those who will enroll in the "selection semester" ("semestre filtro") at another University and then matriculate in Trento in the second semester, different deadlines may be established in light of the implementing decrees to be adopted by the Ministry. In this regard, an addendum to the Call will likely be approved by the end of July, and will be appropriately published on the institution's website.

2. STUDENT AID

The income and merit-based benefits available for "*capable and worthy students regardless of their financial condition*" (Article 34 of the Constitution) are the following:

- scholarship
- [accommodation](#), in collective residences and apartments
- exemption from the [provincial student welfare tax](#)
- total exemption from university [tuition fees](#).

Students of the Advanced School for Linguistic Mediators in Trento and the Trentino Art Academy Advanced Art Institute are not eligible for the total exemption from university [tuition fees](#).

SINGLE-CYCLE MASTER'S DEGREE IN MEDICINE AND SURGERY

Following the approval of the implementing ministerial decrees, the Call for Applications will be amended, in order to establish the terms for accessing benefits for the students concerned, and to set a different deadline for those who, after completing the "selection semester" ("semestre filtro") at another University, will enroll in the degree program in Medicine and Surgery at the University of Trento. This addendum will likely be approved by the end of July and will be appropriately published on the institution's website.

3. REQUIREMENTS

3.1 FINANCIAL CONDITION

According to the Resolution by Provincial Council no. 909 dated June 19th 2026, the financial situation will be determined based on the 2026 [ISEE](#) (Equivalent Financial Situation Indicator) issued for **university education benefits** and [ISPE](#) (Equivalent Asset Indicator).

To qualify for the benefits, the maximum [ISEE](#) limit for university education benefits is **€ 26.000,00** and maximum [ISPE](#) limit is **€ 52.000,00**

Students must meet both limits (ISEE and ISPE) jointly: if one of the two limits is exceeded, the student does not satisfy the financial requirement and is ineligible for the benefit.

3.2 MERIT

Merit is based on the number of [credits](#) earned and recorded by the relevant offices in relation to the year of first enrollment (for clarifications about the meaning of "[year of first enrollment](#)" please carefully read the corresponding entry in the glossary). When calculating merit, Opera Universitaria will not consider any [credits](#) awarded for competencies acquired prior to enrollment (CPA and CMPA).

3.2.1 Years following the first

Students enrolled in years subsequent to the first must fulfill a merit requirement based on the number of [credits](#) earned starting from the [year of first enrollment](#), by the deadlines indicated in [Tables 1](#) and [2](#) in the Appendix (**August 10th 2026** or **September 30th 2026**, depending on the program attended).

For students with disabilities, please refer to [section 8](#).

3.2.2 Bonus

To reach the minimum merit requirement referred to in [Tables 1](#) and [2](#) in the Appendix, in addition to the earned [credits](#), students can also use a bonus of up to a maximum of five (5) credits during their entire university careers.

If the bonus credits are not used during the current academic year, they can be used in subsequent years. If students have already used the bonus credits in previous years to apply for benefits (including during a Bachelor's degree program either at the University of Trento or at another University or Higher Education Institute) the number of available bonus credits will be equal to the difference between the maximum 5 credits and those already used.



Example: a student enrolled for the a.y. 2025-2026 in the Economics and Management degree program (where 40 [credits](#) are required), has earned 36 [credits](#) by August 10th 2026. To obtain the scholarship, the student uses 4 bonus credits, leaving only 1 credit to be used in the subsequent years to reach the minimum merit requirement.

The bonus **cannot be used:**

a) to meet the minimum merit requirement for first-year students for the disbursement of the remaining 50% of the scholarship;

b) to avoid the revocation of the scholarship referred to in [section 7.3](#).

3.2.3 Students transferring to a different degree program within the University of Trento

Students transferring to a different degree program within the University of Trento must meet the merit requirements of the new degree program with reference to their year of first enrollment (as per [Tables 1](#) and [2](#) in the Appendix).

Credits not recognized in the new program cannot be used when applying for benefits in subsequent academic years.

Example: a student enrolled for the a.y. 2025-2026 in the Business Administration degree program who, for the a.y. 2026/2027 transfers to the Economics and Management degree program, must have earned 40 [credits](#) by August 10th 2026, instead of 35.

3.2.4 Students transferring from another University

Students transferring from other universities must fulfill a merit requirement for the new degree program to which they intend to transfer with reference to their year of first enrollment (as per [Tables 1](#) and [2](#) in the Appendix), based on the number of [credits](#) earned and recorded at their former university. [Credits](#) not recognized by the University of Trento cannot be used to apply for benefits in subsequent academic years.

3.2.5 First-year students

All first-year students must meet special merit requirements for the disbursement of the scholarship, as specified in [section 4.2.1](#).



3.2.6 PhD

Students enrolled in PhD courses are required to be regularly registered for the a.y. 2026-2027.

4. SCHOLARSHIP

4.1 AMOUNT

The scholarship amount varies according to the financial situation of the student's [household](#), the municipality of residence and the applicant's housing status.

Students with an [ISEE](#) indicator equal to or less than two-thirds of the threshold value set forth in [section 3.1](#), will be eligible for the maximum scholarship amount determined by the Provincial Council Resolution no. 909 of June 19th 2026 subject to any adjustments provided by Ministerial Decree no. 175 of February 10th 2026.

For students with an [ISEE](#) indicator exceeding two-thirds of the threshold value and up to the maximum limit, the scholarship is progressively reduced down to half of the maximum amount.

For students with an [ISEE](#) indicator less than or equal to half the maximum limit, the scholarship amount due is increased by 15%.

For female students enrolled in [S.T.E.M.](#) programs the scholarship amount is increased by 20% (this increase is not cumulative with the aforementioned 15%).

For those who, starting from a.y. 2022-2023, are simultaneously enrolled in two degree programs, a 20% supplement to the scholarship obtained each year will be granted, provided that they maintain the merit requirements specified in this Call for the program for which they receive the scholarship, as well as those outlined in the Ministerial Decree no. 1320/2021 for the second program, for the entire duration of their studies. This supplement will be paid on a year-by-year basis upon the fulfillment of the respective requirements.

The scholarship amount for the last semester corresponds to half of the annual scholarship amount.

4.1.1 Resident scholarship

The scholarship amount for students residing in "local" municipalities (as listed in [Tables 3](#) and [4](#) in the Appendix), ranges from a minimum of €1,445.08 to a maximum of €2,890.16, depending on their financial situation.

4.1.2 Scholarship for commuting students

The scholarship amount for students residing in “commuting” municipalities (as listed in [Tables 3](#) and [4](#) in the Appendix), ranges from a minimum of €2,095.36 to a maximum of €4,190.72, depending on their financial situation.

4.1.3 Non-resident scholarship

The scholarship amount for students who reside in “non-local” municipalities (as listed in [Tables 3](#) and [4](#) in the Appendix) and who rent accommodation near their program location **for at least 10 months during a.y. 2026-2027 (5 months for students applying for the scholarship for the last semester only)** ranges from a minimum of €3,585.56 to a maximum of €7,171.12, depending on their financial situation.

Students who do not live in accommodations provided by Opera Universitaria are required to upload a copy of the rental agreement registered in their name (or a copy of the housing assignment id staying in a collective residence) to the ONLINE APPLICATION section of the www.operauni.tn.it website **from September 8th 2026 to October 15th 2026**. The agreement must have a minimum term of 10 months during the a.y. 2026-2027 (between September 2026 and August 2027). Students who have submitted a multi-year [rental agreement](#) to Opera Universitaria in previous years must prove its validity for the a.y. 2026-2027 by uploading the supporting documentation to the ONLINE APPLICATION from September 8th 2026 to October 15th 2026 (see [rental agreement](#)). If the multi-year rental agreement includes the “cedolare secca” tax option and was already submitted to Opera Universitaria the previous year, students do not need to upload the contract again; instead, they can self-certify their tenancy by uploading the “Contract self-statement” form, available on the www.operauni.tn.it website in the [Scholarship/Forms](#) section.

PLEASE NOTE

For the purpose of awarding the “non-resident” scholarship, [rental agreements](#) submitted after the October 15th, 2026 deadline will not be considered under any circumstances, except for the cases specified below.

Students enrolling after October 15th 2026 in a Master’s degree or in a PhD program, or who will enroll in another degree program as a result of the re-allocation of vacant places (“scorrimenti di graduatoria”) by the University of Trento, may upload the agreement (or access accommodations provided by Opera Universitaria) by December 31st 2026. In this case, they

will receive a 'non-resident' scholarship for a period proportional to the months of actual tenancy until August 31st 2027.

SINGLE-CYCLE MASTER'S DEGREE IN MEDICINE AND SURGERY

For students who will enroll in the "selection semester" ("semestre filtro") as outlined in Legislative Decree no. 71/2025, different deadlines may be set, depending on the implementing decrees to be adopted by the Ministry. Opera Universitaria will approve an addendum to the Call by the end of July, which will be appropriately published on the institution's website.

Students residing in any municipality who pay for accommodation and meet the regulatory requirements to be considered "independent" are also treated as "not resident" students. To qualify, applicants must demonstrate adequate earned income from employment or similar sources (at least €9,000 per year for at least two years) and must not have resided, for at least two years prior to the application date, in their family of origin's primary residence or in a property owned by the deadlines indicated above.

Students who, upon reaching the age of majority, live away from their family of origin based on a court order ("care leavers"), regardless of their municipality of residence as well as foreign students whose family members reside abroad (even if the student is registered as a resident at the campus location), are also considered "**non-resident**" students. These students must upload their rental agreement by the deadlines indicated above.

"**Commuter**" status is also assigned to:

- residents in "non-local" municipalities who do not rent accommodation in the proximity of their program location;
- residents in "non-local" municipalities who rent accommodation in the proximity of the program location but **fail to upload a copy of their** agreement (or the "Contract self-statement" form for multi-year rental agreement with "cedolare secca") to the ONLINE APPLICATION **by the deadline set out in this Call for application;**
- students residing in "non-local" municipalities who have been assigned [accommodation](#) but, for any reason, do not directly pay the housing fee because they receive free accommodation or benefit from a rent subsidy granted by the University of Trento or another institution.

For students spending time in Italy or abroad for internships or international mobility programs, funded by Opera Universitaria, the University of Trento or another Institution, the “non-resident” scholarship will be disbursed only for the months actually spent in Trento (as proven by the agreement). A “resident” scholarship will be disbursed for the months spent elsewhere, provided that the total combined period spent in Trento and at the host institution is at least 10 months. If the student submits an agreement of at least 10 months by October 15th 2026 and subsequently participates in the Erasmus+ program, they will be required to repay part of the non-resident scholarship during the second semester, once the University of Trento confirms their actual departure abroad.

Students participating in internships, thesis research, or other international mobility programs outside the Province of Trento or abroad may retain the full amount of their “non-resident” scholarship only if all the following conditions are met:

- participation in the study or research project is certified by the University of Trento;
- they do not benefit from any other scholarship, grant or financial remuneration for the same mobility period;
- they submit a copy of the agreement, (either in Italy or abroad), covering a total rental period of at least 10 months.

For students with disabilities, please refer to [section 8](#).

4.2 DISBURSEMENT

The scholarship will be disbursed to eligible students exclusively via bank transfer to a current account (or credited to a prepaid card equipped to receive bank transfers without amount limits) **held or jointly held in the student’s name**. When filling out the application, and in any case no later than October 31st 2026, students must provide their [IBAN](#) code by clicking on “Accedi ai dati anagrafici e bancari” (Access personal and bank details). If the deadline is missed, the scholarship (if due) will be credited starting February 2027.

4.2.1 First-year students

To receive the full scholarship amount, students must meet specific merit requirements based on the number of [credits](#) earned and recorded by the relevant offices during their studies. Any credits awarded for competencies acquired prior to enrollment (CPA and CMPA) will not be considered in the merit calculation.

For students with disabilities, reduced merit requirements apply as specified in [section 8](#).



Students enrolled in **Bachelor's degree programs, first-level courses or single-cycle Master's degree programs** will receive **20%** of the total scholarship amount by November 10th 2026. A further **30%** of the total amount will be disbursed by December 2026.

Those enrolling in a **Master's degree program** by October 31st 2026, will receive **50%** of the total scholarship amount within December 2026. Students enrolling in a **Master's degree program** after October 31st 2026 will receive **50%** of the total scholarship amount by February 2027.

The remaining **50%** of the total scholarship amount will be disbursed upon earning the number of [credits](#) required for students enrolled in the a.y. 2025-2026 as per [Tables 1](#) and [2](#) in the Appendix, by the indicated deadlines (**August 10th** or **30th September 2027**, depending on the program attended).

First-year students enrolled in new degree programs activated by the University of Trento in the a.y. 2026-2027 (Environment and Workplace Prevention Techniques, Biomedical Laboratory Techniques, and Imaging and Radiotherapy Medical Radiology Techniques) are required to earn **35 credits** by **September 30th 2027** to meet the merit requirement and receive the remaining 50% balance of the scholarship.

For students with disabilities, please refer to [section 8](#).

PLEASE NOTE

Bonus credits cannot be used to meet the merit requirement for the disbursement of the remaining 50% of the total scholarship amount. The disbursement of this amount will be made automatically, upon verification of the required merit recorded in the student's academic career, starting from March 2027.

For students who will enroll in the "selection semester" ("semestre filtro") as outlined in Legislative Decree no. 71/2025, different deadlines for payments may be set, depending on the implementing decrees to be adopted by the Ministry. Opera Universitaria will approve an addendum to the Call by the end of July, which will be appropriately published on the institution's website.



4.2.2 Years following the first

The scholarship will be paid also subject to the resource availability, either in a single installment by the end of December 2026, or in two installments, with the first disbursed by the end of December 2026. In the case of payment in two installments, and subject to the availability of funds, the full amount may be awarded first to beneficiaries in a more disadvantaged economic situation.

4.2.3 PhD

For eligible students enrolled in PhD programs, the scholarship will be paid in a single installment within 60 days following the approval of the ranking list, provided they are regularly enrolled in the a.y. 2026-2027.

5. TUITION FEES EXEMPTION

5.1 UNITRENTO STUDENTS

Students eligible for a scholarship under this Call for Application and beneficiaries of the Ministry of Foreign Affairs scholarship for the a.y. 2026-2027 are entitled to total exemption from tuition fees and provincial student welfare tax. Students who lose their eligibility for a scholarship will be required to pay the University of Trento the fees due for the a.y. 2026-2027. These fees will be calculated according to the specific ISEE for welfare benefits related to the right to university education (locally known as "ISEE Università"), valid for the year 2026, requested as indicated by INPS and within the timeline set out in the "[Guida all'ISEE università e all'ISEE Parificato](#)" page available on the University's Service Desk.

5.1.1 No exemption

Students who are not eligible for a scholarship and, therefore, do not qualify for exemption will be required to pay tuition fees. After the scholarship ranking list is approved, the amount due will be visible in the [Esse3](#) personal area (MyTasse) and on the UniTrentoApp under the "Taxes/ISEE" menu item. Students who enroll after the ranking list approval must notify the University of Trento that they are not eligible for the tax exemption.

Tuition fees for Bachelor's, Master's and single-cycle degree programs will be calculated based on a compliant version of the "ISEE Università" valid for the year 2026. Details on how to submit the ISEE calculation and the relevant payment deadlines are available in the "[Guida all'ISEE università e all'ISEE Parificato](#)" page on the University's Service Desk. A late payment penalty will be charged for any payment made after the due date indicated on the Pago PA payment notice.

5.1.2 Exemption first year “Fuori Corso” (Students enrolled in their first year Beyond the standard duration of their degree program)

Master’s degree and single-cycle Master’s degree students eligible for the scholarship, who intend to enroll in the a.y. 2026-2027 for their first year beyond the standard duration of their degree program (with reference to the year of first enrollment) can benefit from **partial** exemption: they will be required to pay the University of Trento, in addition to the stamp duty, an amount equal to half of the tuition fees. This amount may be further reduced based on a compliant “ISEE Università” valid for the year 2026, following the procedures and deadlines indicated on the [Tasse Universitarie](#) page on the University website. After the scholarship ranking list is approved, the amount due will be visible in the [Esse3 personal area](#) (Mytasse). A late payment penalty will be charged for any payment made after the due date indicated on the Pago PA payment notice.

5.1.3 Exemption for students with Bachelor’s Degrees earned after September 7th 2026, who intend to enroll in the first year of a Master’s Degree Program from September 8th 2026 until the deadline set by each Departments/Centers

Students who will earn a Bachelor’s degree after September 7th 2026 and who intend to enroll in the first year of a Master’s degree program at University of Trento from September 8th 2026 until the deadline set by each Department/Center, must still submit their scholarship application by September 7th 2026. In the event of non-eligibility for the scholarship upon enrollment in a degree program at UniTrento, the student must notify the University of their non-eligible status and pay the first installment of tuition fees, as well as any subsequent installments. These fees are calculated based on the compliant “ISEE Università” valid for the year 2026, according to the procedures specified on the [Tasse Universitarie](#) page of the University website. All amounts due will be displayed in the [Esse3](#) personal web area (Mytasse). A late payment penalty will be charged for any payments made after the due date indicated on the Pago PA payment notice.

For information regarding exemptions for students with disabilities, please refer to [section 8](#).

PLEASE NOTE

The “ISEE Università” calculation required for the reduction of standard tuition fees at UniTrento for the academic year 2026-2027 must be valid for the year 2026. It must be requested



from INPS by submitting the Dichiarazione Sostitutiva Unica(DSU) following to the procedures and deadlines indicated on the "[Guida all'ISEE università e all'ISEE Parificato](#)" page available on the University's Service Desk. In the absence of the compliant version of the "ISEE Università" valid for the year 2026, submitted within the deadlines indicated on the University Fees page for the a.y. 2026-2027, the maximum amount of tuition fees must be paid.

5.2 CONSERVATORY OF MUSIC

Students eligible for a scholarship are entitled to total exemption from [university tuition fees](#) and the [provincial student welfare tax](#). Students who lose their eligibility to receive a scholarship during the academic year will have to pay the [provincial student welfare tax](#) to Opera Universitaria calculated according to the "[ISEE Università](#)", in the manner that will be communicated to them by the administrative office of the Conservatory of Music.

Students ineligible for the scholarship will have to pay the [provincial student welfare tax](#) to Opera Universitaria by **November 30th 2026**, calculated according to the [ISEE](#) system, as indicated on the Conservatory's website.

5.3 SSML, TRENTINO ART ACADEMY AND PHD STUDENTS

Students eligible for a scholarship are entitled to exemption from the [provincial student welfare tax](#). Students who are not exempt from the [provincial student welfare tax](#) must pay €150.00 **by November 30th 2026**, according to the procedures that will be notified by SSML or by the Trentino Art Academy or as set out on the University portal for PhD students.

6. ACCOMMODATION

Students who meet the financial situation and merit requirements as per [section 3](#) and reside in a "non-local" municipality, are eligible for [accommodation](#) at a reduced rate. The "non-local" municipalities of residence are listed in [Tables 3](#) and [4](#) in the Appendix.

Students who, upon reaching the age of majority, live away from their family of origin, based on a court decision ("care leavers") and foreign students who have a household residing abroad, and meet the economic and merit requirements specified in this Call, can request accommodation at a reduced rate regardless of their place of residence.

6.1 CONFIRMATION OF ACCOMMODATION

Students who received the scholarship and [accommodation](#) for the a.y. 2025-2026 can confirm their housing for the a.y. 2026-2027 by **completing the ONLINE APPLICATION by August 5th 2026** provided that they have an active assignment record with Opera Universitaria at the time of submission and meet the financial



requirements outlined in [section 3.1](#), as well as the merit requirements listed in [Tables 1](#) and [2](#) in the Appendix.

To confirm their accommodation, the current assignment record must expire on August 31st 2026 (July 31st 2026 for students living in the Barelli residence in Rovereto).

Students enrolled in a Bachelor's degree program in the a.y. 2023-2024, who received the scholarship for a.y. the 2025-2026 and wish to confirm their [accommodation](#) for the a.y. 2026-2027, must have earned and registered at least **140 credits by August 10th 2026 (by September 30th for students attending a course at the Conservatory)**. If a student graduates from their Bachelor's degree by August 5th 2026, they can confirm their accommodation for a Master's degree, provided that enrollment happens by the same date (otherwise the student will have to request a new housing assignment).

6.2 NEW ASSIGNMENTS

Opera Universitaria provides **300 accommodation places in Trento and 40 in Rovereto**, which will be assigned by the first week of September 2026. Accommodation is assigned automatically on an annual basis. If additional places become available, further assignments may be made.

Students eligible for accommodation according to the ranking list must confirm their acceptance **within 2 days of the date of ranking list approval**. Students will receive an e-mail with instructions on how to accept the [accommodation](#) offered. Failure to accept by the specified deadline will be considered as a forfeiture of the accommodation.

In the event of withdrawals or declined offers, eligible students will be contacted via email according to their ranking order: they will also have **2 days** to confirm their acceptance of the [accommodation](#).

PLEASE NOTE

Students enrolled at the University of Trento will be contacted via their university email address, it is therefore necessary to activate the university account immediately. Students are strongly advised to check their email (both the university and personal email addresses) daily during the housing assignment period.

Please refer to [section 10.2](#) for the [accommodation](#) application deadlines.

Information for students with disabilities can be found in [section 8](#).

6.3 PAYMENT:

The monthly accommodation fees at a reduced rate are as follows:

- double room: €190,00 per month;



- single room: €230,00 per month.

In addition to the monthly fee, the student must also pay a non-interest-bearing deposit of €360.00 and a final cleaning charge of €40.00.

The payment methods for the monthly rent and deposit will be communicated along with the accommodation assignment.

Accommodation fees are due as follows:

- by 30 November 2026, for the rent covering the period until December 2026;
- in bimonthly installments, to be settled by the end of the first month of the bimonthly period, for the period from January 2027 until August 2027.

The deposit of €360.00 will be refunded at the end of the accommodation assignment in accordance with the terms and conditions set out in the Regulations governing the use of Opera Universitaria accommodation facilities available on the website www.operauni.tn.it, within 60 days following the expiration date of the assignment.

Payment delays and installments plans are not allowed. **In the event of non-payment of the amounts due, the [accommodation assignment](#) will be revoked. Interest and expenses will be charged on overdue amounts and collected according to the ordinary enforcement procedures (credit recovery through Trentino Riscossioni).**

7. DURATION, EXCLUSION AND REVOCATION OF BENEFITS

7.1 DURATION OF BENEFITS

The benefits under this Call are awarded as follows:

- for students enrolled in **Bachelor's degree programs**:
 - scholarship and tuition fee exemption ([provincial student welfare tax](#) for the Advanced School for Linguistic Mediators SSML and the Trentino Art Academy) for a period corresponding to the standard duration of the respective study programs, starting from the year of first enrollment;
 - [accommodation](#) for a period corresponding to the standard duration of the study program, plus one year for those who can confirm their [accommodation](#).
- for students enrolled in **Master's degree programs and single-cycle Master's degrees programs**:
 - scholarship and tuition fee exemption for a period corresponding to the standard duration of the study program



plus one semester (the amount of the scholarship for the last semester is 50% of the annual scholarship), starting from the [year of first enrollment](#). The amount for the last semester will not be disbursed if the student graduates by October 31st 2026;

- [accommodation](#) for a period corresponding to the standard duration of the study program, plus one year starting from the [year of first enrollment](#).
- for students enrolled in **part-time programs and PhD programs**:
 - scholarship, tuition fee exemption and [accommodation](#) for a period corresponding to the standard duration of the study programs, starting from the [year of first enrollment](#).
 - Please refer to [section 8](#) for the duration of benefits for students with disabilities.

7.2 EXCLUSION FROM BENEFITS

The following students are excluded from the benefits envisaged in this Call for Application:

- students who are 35 years old or older as of January 1st 2026
- students enrolling in a study program of the same level as a degree already obtained (those who hold a first-cycle degree and are enrolling in a single-cycle Master's degree program may request benefits starting from the 4th year)
- students who gain recognition or equivalence of an academic qualification obtained abroad, if it is of equivalent or higher value than the one they are enrolling in
- students enrolled in foreign universities attending the University of Trento as part of international mobility programs
- students who benefit, for the a.y. 2026-2027, from other financial support provided under the same criteria (economic situation and merit)
- students who are citizens of Non-EU States and who do not reside in Italy, at the time of admission to study programs, regardless of any changes in residence that occurred after the start of their university studies
- students who do not meet the financial and/or merit requirements set in this Call
- students who were previously enrolled in a degree program of the same level as the one they are enrolling in for the a.y. 2026-2027, with the exception of those who withdrew from their studies immediately or, in any case, no later than the end of October

- students who enrolled in a study program of the same level as the one in which they are enrolling in for the a.y. 2026-2027, except for students who meet all the following requirements:
 - who enrolled for the first time in the Italian University System in a Bachelor or single-cycle Master's degrees program in the a.y. 2025-2026
 - who withdrew from their studies at the end of the first year and intend to enroll for the a.y. 2026-2027 in a course within a different degree class
 - who returned any benefits received for the a.y. 2025-2026
 - who paid all debts owed to the University and/or the Student Welfare Institution
 - who did not obtain any [credit](#) transfers from previous studies
- students previously enrolled in a study program of the same level, **except** for students who meet all the following requirements:
 - who enrolled for the first time in the Italian university system in a Bachelor's or single-cycle Master's degree program in the a.y. 2020-2021 or in subsequent academic years
 - who withdrew from their studies at the end of the first year and enrolled, in the immediately following academic year, in a degree program belonging to a different degree class
 - who returned any benefits received for the former degree program
 - who paid all debts owed to the University and/or the Student Welfare Institution
 - who did not obtain any [credit](#) transfer from previous studies
- students who enrolled in a study program of the same level, **except** for students who meet all the following requirements:
 - who enrolled for the first time in the Italian university system in a Bachelor's or single-cycle Master's degree program in the a.y. 2020-2021 or in subsequent academic years
 - who withdrew from their studies at the end of the first year and enrolled in the immediately following academic year in a single-cycle Master's degree program
 - who did not obtain any credit transfer from previous studies
 - who requested benefits starting from the 4th year
- students enrolled at the same time in two study programs, who intend to apply for benefits on the second year program, having already received the same benefits on the first one
- students enrolled in inter-university programs, whose administrative headquarters of enrollment is an institution other than the University of Trento
- students enrolled in a first or second level academic diploma course of the "F.A. Bonporti" Conservatory of Music who have already earned a degree issued at the end of a course under the previous Conservatory's system.



7.3 REVOCATION OF BENEFITS

The scholarship and tuition fees exemption will be revoked for students who are:

- enrolled in the first year and do not earn at least 20 [credits](#) (12 [credits](#) for the part-time Business Management program) by August 10th 2027 or who transfer to another university or withdraw from their studies without having met this same merit requirement. In the event of a transfer from the University of Trento to another university, students may obtain such authorization only after returning the benefits received;
- enrolled in the first year of PhD programs and withdraw from their studies during the first year or do not enroll in the second year
- enrolled in years following the first year who withdraw from their studies by March 31st 2027.

PLEASE NOTE

To meet the merit requirement for maintaining the 50% scholarship amount, it is not possible to use bonus [credits](#).

In the event of scholarship revocation, the amount received must be returned to Opera Universitaria **by December 31st 2027**, according to the procedures communicated by Opera Universitaria (a notice containing payment instructions will be sent via email). Failure to return this amount by the set deadline will result in a late payment penalty of €50,00 and the payment of the due amount plus interest and expenses, which will be collected according to ordinary enforcement procedures (i.e., debt recovery through Trentino Riscossioni).

The revocation of the scholarship benefit also entails the payment of [tuition fees](#).

For information regarding the payment of tuition fees in case of scholarship revocation, students of the University of Trento can find details on the following [page](#), while students attending the Conservatory of Music can contact their respective administrative office.

Those who enroll at another university at the end of the "selection semester" ("semestre filtro") (Legislative Decree no. 71/2025) will lose their benefits and their accommodation will be revoked.

The [accommodation](#) benefit will be revoked in the cases specified in the Regulations governing the use of Opera Universitaria accommodation facilities, which can be found on the website www.operauni.tn.it in the "[Alloggi](#)" section.

For students with disabilities, please refer to [section 8](#).



8. INFORMATION FOR STUDENTS WITH DISABILITIES

Without prejudice to the provisions set forth herein, the following is specified.

Students with disabilities, as identified pursuant to Article 3, paragraph 1, of Law no. 104 of February 5th 1992 or with a disability equal to or greater than 66%, are entitled to total exemption from [tuition fees](#) and from the [provincial student welfare tax](#) for the entire course of study, regardless of their [household's](#) financial situation. Students must apply for this benefit upon registration or enrollment at the University.

The duration of scholarships and accommodation benefits for students with disabilities equal to or greater than 66% or with disabilities identified pursuant to Article 3, paragraph 1, of Law no. 104 of February 5th 1992, will be as follows:

- nine semesters for Bachelor's degree programs
- seven semesters for Master's degree programs
- thirteen semesters for single-cycle Master's degrees programs in Law and Building Engineering-Architecture
- fifteen semesters for the single-cycle Master's degree programs in Medicine and Surgery

starting from the [year of first enrollment](#).

The amount of the scholarship can be increased up to a maximum of 40% based on the student's disability to allow for the use of prostheses and other prosthetic supports, and all other measures aimed at facilitating access to educational activities and studying.

All students with disabilities, identified in accordance with Article 3, paragraph 1 of Law no. 104 of February 5th 1992, or with a disability of 66% or more, will be subject to merit requirements reduced by 40%. A merit requirement of 84 [credits](#) will be required to obtain benefits for the seventh semester in Bachelor's degree programs. For the last semester, students will be required to earn at least an additional 6 [credits](#) above the merit requirement for the previous semester (in addition to any educational obligations stipulated upon admission to the courses).

The University Inclusion Service ("Servizio Inclusione Comunità studentesca") is available for online scholarship application assistance and for any requests regarding specific services and equipment.

Students with disabilities residing in a "non-local" or "commuter" municipality (as identified in [Tables 3](#) and [4](#), in the Appendix) and meeting the economic and merit requirements will be guaranteed an accommodation place at a reduced rate. Students with disabilities will be provided with accommodation without architectural barriers, designed for their specific needs, within the limits of availability. These needs must be notified to Opera Universitaria when filling out the online Call for

Application form. Without specific notification, the room will be assigned automatically.

Students with disabilities who do not meet the economic eligibility requirements specified in the Call but are interested in requesting accommodation can find the relevant information in the Accommodation section on the Opera Universitaria website www.operauni.tn.it/alloggi.

The University Inclusion Service ("Servizio Inclusione Comunità studentesca"), located at Via Tommaso Gar 16/2, is open from Monday to Friday by appointment only (tel. 0461/282128 – email: inclusione.studente@unitn.it).

9. CERTIFICATION OF FINANCIAL CONDITION

In order to submit the application for benefits, students need the "[Attestazione ISEE per prestazioni agevolate per il diritto allo studio universitario](#)" valid for the year 2026 (in the cases specified in [section 9.1](#)) or the "[ISEE parificato](#)" **2026** (in the cases specified in [section 9.2](#)). The [ISPE](#) value will be calculated by Opera Universitaria based on the data provided by INPS.

The limit values to access the benefits referred to in section 2 are:

[ISEE](#) Università **€ 26.000,00**,

[ISPE](#) **€ 52.000,00**.

9.1 STUDENTS WHOSE HOUSEHOLD IS IN ITALY

Before submitting the application for benefits, students must submit the [Dichiarazione Sostitutiva Unica](#) (DSU) - which contains information about the [household](#), as well as the income and assets of each household member - directly on the INPS website (www.inps.it) or by contacting a Tax Support Centre (CAF) or other authorized entity.

The scholarships disbursed in the calendar year 2024 must be declared when requesting the ISEE.

Obtaining the "[Attestazione ISEE per il diritto allo studio universitario](#)" takes about 10 working days from the submission of the [Dichiarazione Sostitutiva Unica](#) (DSU). Therefore, students are strongly advised to request the [Attestazione ISEE](#) well ahead of the deadline in order to complete the application for benefits within the deadlines set in [section 10.2](#).

PLEASE NOTE

Only the [Attestazione ISEE](#) for the year 2026 (requested from January 2026) will be accepted, and they must include the following statement: "si applica alle PRESTAZIONI AGEVOLATE PER IL DIRITTO ALLO STUDIO UNIVERSITARIO" followed by the tax code of the student applying for the benefits.



Attestazioni ISEE that are not applicable to subsidized benefits for the right to university education, or that are requested after the application deadline for benefits referred to in [section 10.2](#), will not be considered.

In the case of two or more students belonging to the same **household**, for the purpose of validating the benefit applications, the **Attestazione ISEE** must include the statement "si applica alle prestazioni agevolate per il diritto allo studio universitario" followed by the tax codes of all applicants.

If a student makes changes to their [Dichiarazione Sostitutiva Unica](#) (DSU) Opera Universitaria must be immediately notified.

Students are required to check whether their [Attestazione ISEE](#) contains any note of omissions/discrepancies and is therefore [not-compliant](#). In such a case, a new [DSU](#), must be submitted no later than October 15th 2026. This new DSU must include the information previously omitted or otherwise misstated, and Opera Universitaria must be promptly informed.

If the student has requested the [ISEE corrente](#), it must be valid on the date of application submission.

9.2 STUDENTS WHOSE HOUSEHOLD IS ABROAD

Students whose [household](#) is abroad must submit the documentation described in the following paragraphs to the **CAF affiliated with the University of Trento**, within the deadline specified in [section 10.2](#), in order to obtain the [isee parificato](#). To book an appointment, students must complete the relevant online procedure according to the instructions indicated on the "[Guida all'ISEE università e all'ISEE Parificato](#)" page available on the University's Service Desk. After obtaining the [ISEE parificato](#), they will need to send a copy of the [Attestazione ISEE parificato](#) to the email address operauniversitaria@pec.operauni.tn.it and then complete the online application.

9.2.1 Students with family unit in an EU country

Students whose [household](#) is in an EU country must submit the following documentation regarding their household financial condition, translated into Italian: a family status and residence certificate; and, for all [household](#) members, their income for the year 2024, the floor area (square meters) of their main dwelling and other properties, and their bank deposits as of 2024.

9.2.2 Students residing in Italy with family unit in a non-EU Country

Students residing in Italy whose [household](#) is in a non-European Union country, must submit the following documentation about their family financial condition:



- for students from [particularly poor countries](#), their financial condition will be assessed based on a certificate issued by the Italian diplomatic authorities in their country of origin. This certificate can also be issued by the Italian bodies authorized to issue financial guarantees in compliance with the relevant legal provisions concerning the enrollment of foreign students at Italian universities
- for students from other non-EU countries, certificate issued by the relevant authorities in their country of origin translated into Italian and authenticated by the Italian diplomatic authority having jurisdiction (Embassy or Consulate) certifying that it complies with the original and documenting the [household](#) composition and residence, as well as the income for the year 2024, the floor area (square meters) of the main dwelling and other properties, and the bank deposits as of 2024 for all household members. For those countries where particular difficulties are encountered in obtaining certificates from a local Italian Embassy, the documents in question can be issued by the competent foreign diplomatic or consular representatives in Italy and legalized by a Prefecture.

All students with their [household](#) abroad are still obliged to declare any income and assets held in Italy by their [household](#).

The financial condition of stateless students and of students who have obtained recognition of their “international protection” status (political refugees) shall be assessed by considering only the income and assets they may possess in Italy.

10. SUBMITTING THE APPLICATION FOR BENEFITS

10.1 HOW TO FILL IN THE APPLICATION

The application for benefits must be submitted exclusively online through the Opera Universitaria website www.operauni.tn.it within the deadlines specified in [section 10.2](#), by clicking on “**[ONLINE APPLICATION](#)**” and following all instructions.

To access the electronic procedure, students at the University of Trento can use their SPID credentials, the Electronic Identity Card (CIE), or credentials issued by the University. For students of other institutes, the SPID credentials or the Electronic Identity Card (CIE) are required to access the procedure

PLEASE NOTE

In the “Economic Condition” section of the ONLINE APPLICATION, the most recent valid [Attestazione ISEE](#) 2026 must be selected by clicking the “Select” button.



As the deadlines set in [section 10.2](#) approach, if the student has not yet obtained the '[Attestazione ISEE per prestazioni agevolate per il diritto allo studio universitario](#)', they may enter the reference number of the [Dichiarazione Sostitutiva Unica](#) (e.g. CAF000XX-PG0000-2026-N0000000) in the online application. Opera Universitaria will then receive the "Attestazione" by querying the ISEE information system or, in the event of technical issue, by requesting it directly from the declarant.

In order to be awarded a "non-resident" scholarship, the agreement referred to in [section 4.1.3](#), must be uploaded during the online procedure, in PDF format, **starting from September 8th 2026, and no later than October 15th 2026.**

PLEASE NOTE

Only applications fully completed in every required part of the online procedure and DEFINITELY SUBMITTED by the deadlines indicated in [section 10.2](#) will be accepted. If the application is submitted correctly, a receipt will be issued and sent to the provided e-mail address. This receipt must be kept as proof of submission.

Any technical issues preventing the online submission of the application must be promptly reported to the Opera Universitaria help desk via email operauniversitaria@pec.operauni.tn.it, always indicating the student's surname, name and tax code, as well as a description of the reported error/malfunction, within the deadlines specified in [section 10.2](#). Reports sent after the deadline will not be considered.

10.2 WHEN TO SUBMIT THE APPLICATION

Students can submit their online application as of **July 13th 2026**, within the following deadlines:

- **by August 5th 2026** if the applicant also intends to confirm the [accommodation](#) currently in use
- **by August 19th 2026** if the applicant is also applying for new accommodation assignments
- **by September 7th 2026** if the applicant is only applying for the scholarship and tuition fees exemption.

Students enrolled in PhD programs may apply for the scholarship, the exemption from the [provincial student welfare tax](#) and [accommodation](#) **from July 13th 2026 to November 30th 2026.**

The application for benefits must be submitted irrespective of actual enrollment in the a.y. 2026-2027. Different enrollment deadlines may



be set after the application submission deadline, meaning that students must apply even if they do not know the admission test results or have not yet enrolled in the program for which they are submitting the application (for example, a student not yet enrolled in a Master's degree program on September 7th 2026 must still submit the application for benefits within the deadlines set out in [section 10.2](#)).

SINGLE-CYCLE MASTER'S DEGREE IN MEDICINE AND SURGERY

For those who enroll in the "selection semester" ("semestre filtro") at another university and matriculate in Trento for the second semester, different deadlines may be established in light of the implementing decrees to be adopted by the Ministry. In this regard, an addendum to the Call for Applications will likely be approved by the end of July, and will be appropriately published on the Institution's website.

PLEASE NOTE

In the case of "[Attestazione ISEE](#)" containing omissions or discrepancies, a new [DSU](#) must be submitted promptly, no later than October 15th 2026. This new DSU must include the previously omitted or incorrectly reported information, with timely notification given to Opera Universitaria.

PLEASE NOTE

For the purpose of awarding the "non-local" scholarship, rental contracts submitted after the October 15th 2026 deadline will not be considered under any circumstances. Students residing in "non-local" municipalities who do not upload their [rental agreement](#) by the deadline will be automatically classified "commuting students".

11. APPROVAL OF RANKINGS AND APPEALS

Opera Universitaria will approve the accommodation rankings list **within the first week of September 2026**.

The scholarship ranking list will be approved **by October 31st 2026**. The ranking list of scholarships and accommodation for students enrolled in PhD programs will be approved **by December 31st 2026**.

The outcome of the submitted application can be checked by accessing the [ONLINE APPLICATION](#) on the www.operauni.tn.it website and



clicking on "Visualizza esito/Application outcome": students from the University of Trento must use their SPID credentials, the Electronic Identity Card (CIE) or credentials issued by the University; for students of other institutes, the SPID credentials or the Electronic Identity Card (CIE) are required to access the procedure.

The scholarship will be awarded to eligible students based on their rankings, using available funds from the regional student welfare tax, provincial funding, and any additional allocations, if they become available, from the National Recovery and Resilience Plan (PNRR).

The University of Trento will notify students who are not eligible for a scholarship of the terms and deadlines for paying [tuition fees](#).

An administrative appeal against the measure approving the ranking list is admissible within 30 days to Opera Universitaria (as provided for by Art. 4 paragraph 1, letter g) of the Regulation on the "functions of the Board of Directors and administrative management of the Director", in compliance with the provisions of Presidential Decree no. 1199 of November 24th 1971 ("Simplification of procedures concerning administrative appeals"), sending an e-mail to operauniversitaria@pec.operauni.tn.it. The subject line of the communication must indicate: "Ricorso".

The appeal, accompanied by the appellant's identity document, must contain the grounds, any supporting documents, all the appellant's identifying information, the date and signature.

Opera Universitaria's offices are available to carry out a preliminary and informal assessment of the appeal's admissibility. In this case, students may contact Opera by sending an email to borse@operauni.tn.it and explaining the issue, without further formalities.

12. REPORTING OBLIGATIONS

Should any changes occur in the data provided after submitting the application, the student must promptly notify the Sportello Opera Universitaria (Opera Universitaria Help Desk), particularly in the following circumstances:

- transfer to another degree program
- transfer to another university
- withdrawal from studies
- changes in the information provided in the scholarship application (residence, bank details, financial condition, etc.)
- award of another scholarship or other financial aid
- recognition of exams during the year (and consequent recalculation of benefits granted, considering the [year of first enrollment](#))
- completion of the degree

- amendment to the [rental agreement](#)
- participation in international mobility programs (for students who reside in “non-local” municipalities, as identified in [Tables 3](#) and [4](#) in the [Appendix](#)).

13. OTHER INITIATIVES

SUBSIDY OR OTHER EXTRAORDINARY INTERVENTION

In cases of entirely exceptional and unforeseen situations of serious financial hardship occurring after the time limit envisaged for standard student funding, and in any case taking into account the guiding principles of this Call for Applications, or of documented objective circumstances preventing the merit requirements from being fulfilled, Opera Universitaria reserves the right to intervene by granting special extraordinary grants, an extension of the time limit for fulfilling the required merit, or the allocation of accommodation at a reduced rate. The Commission may assess special situations arising from a student's transfer from another university or grant the scholarship to students already holding a Bachelor's degree in Italy who intend to enroll in a single-cycle degree program or holding a degree obtained abroad, taking into account the reference principles of this Call and the maximum duration of the benefits envisaged.

The special grant cannot be considered an alternative to the scholarship if the relevant requirements have not been satisfied, or if the deadline for submitting the ordinary application has not been met.

The extraordinary intervention is of an exceptional nature and can therefore be requested only once during the course of study (for those enrolled in single-cycle Master's degree programs, it can be requested twice, provided that the events are different and of particular severity).

The student must adequately document their condition of need and send the request to the certified email address operauniversitaria@pec.operauni.tn.it by the deadlines specified in [section 10.2](#) of the Call. In the event of serious health reasons documented by a certification issued abroad, this documentation must be provided according to the procedures specified in documentation [section 9.2](#) of the Call.

The application for the subsidy or other extraordinary intervention will be assessed by a panel composed of members of the Board of Directors

INTERNSHIP ABROAD

Recipients of Opera Universitaria scholarships who carry out an internship abroad in a country of which they are not citizens may receive an additional monthly allowance of €600,00, for a period of up to 4 months, provided they are not recipients of the allowance assigned by the University of Trento under the call for applications for internships

abroad or another scholarship or remuneration granted for the same project.

For students in a Master's degree or single-cycle Master's degree programs who are enrolled in their first year beyond the standard duration of the study program – with reference to the [year of first enrollment](#) – the allowance will be calculated only for the internship period completed by March 31st 2027.

Opera Universitaria will disburse the benefit at the end of the completed internship, based on the official communication from the University of Trento.

14. ACCURACY OF DECLARATIONS

Opera Universitaria verifies the accuracy of the statements made by students as of the expiration date for submission of the applications and also after delivery of the benefits, pursuant to Article 71 of Presidential Decree no. 445/2000, Article 10 of Legislative Decree no. 68/2012 and Article 11 of Prime Ministerial Decree n. 159/2013 and in conformity with the resolution of the Board of Directors of Opera Universitaria no. 29 of November 8th 2010.

If the content of the statement submitted by the student is found to be inaccurate after verification, the assigned benefits will be revoked and an administrative penalty equal to three times the amount received will be imposed. The student will also lose their right to receive further allowances at any time during their study program.

Opera Universitaria will report the matter to the judicial authority for the possible application of criminal laws for actions constituting an offense. Students are therefore strongly advised to exercise the utmost care and rigor when presenting their statements.

15. PROCESSING OF PERSONAL DATA

INFORMATION ON THE PROCESSING OF PERSONAL DATA pursuant to Article 13 of EU Regulation 2016/679 on the protection of individuals with regard to the processing of personal data (hereinafter referred to as 'Regulation' or 'EU Regulation').

Opera Universitaria of Trento provides the following information about the processing of your personal data pursuant to Article 13 of European Regulation 2016/679.

1. Purpose and methods of data processing

To implement the aims of Opera Universitaria of Trento, as set forth by Provincial Law no. 9 of May 24th 1991 establishing the institution, and to provide the services envisaged by said law, your personal data will be collected and processed:

- a. to verify the requirements for access to student welfare benefits



- according to the criteria set out in this Call for Applications and for any other purpose required by law;
- b. for procedures connected with the assignment of scholarships, places and related services, the exemption from the [provincial student welfare tax](#) and [tuition fees](#) and for the other benefits envisaged by this Call for Applications;
 - c. to process statistical reports in aggregate and anonymous form;
 - d. subject to your prior explicit consent, pursuant to Article 6.1, (a) of the EU Regulation, for ancillary purposes such as monitoring the quality of services to assess users' satisfaction with the services offered.

In relation to the aforementioned purposes, the processing of data by Opera Universitaria will be carried out in compliance with the principles of lawfulness, fairness and transparency, protecting your privacy and that of your family members, in compliance with the principles set out in Article 5 of the EU Regulation. The processing can be performed manually, using printed documents as well as with the aid of electronic or automated means. Data are collected and processed at the Opera Universitaria offices using appropriate document archives/servers. Opera Universitaria shall take all necessary measures to promptly correct any inaccurate data relevant to the processing purposes.

Your personal data is processed using appropriate technical and organizational security measures in accordance with Article 32 of the EU Regulation, to guarantee a security level appropriate to the risk, thereby minimizing the risks of destruction or loss, processing that does not comply with the purpose of the collection.

Your personal data are not the subject to any automated decision-making or profiling process.

With reference to the special categories of personal data that can reveal your racial or ethnic origin, your state of health or the state of health of your family members, as per Article 9, paragraph 1 of the EU Regulation, processing shall be carried out in proportion to the purpose pursued, while also adopting appropriate and specific measures to protect your fundamental rights.

2. Obligation to provide personal data

To achieve the purposes set forth by Provincial Law no. 9 of May 24th 1991 establishing Opera Universitaria, the provision of personal data is mandatory. Refusal to provide personal data will make it impossible for Opera Universitaria to pursue the purposes referred to in section 1(a), (b), and (c).

While providing data for the purposes referred to in section 1(d) is optional, failure to do so will make it impossible to pursue the purposes stated thereunder.

3. Scope of data circulation and communication



Your personal data will be disclosed to Opera Universitaria employees authorized to process the data, or to natural or legal persons who provide consulting services or cooperate with Opera Universitaria for the purpose of providing the student welfare benefits.

Opera Universitaria may need to disclose your personal data to external parties it trusts or to professional bodies such as public, institutional or professional entities that are authorized by law to request such data, or to third-party companies or professionals who provide services to Opera Universitaria. These entities and companies shall process data as independent data controllers or "Data Processors" duly appointed based on contractual agreements drawn up in compliance with the provisions of Article 28 of the EU Regulation.

Data may be disclosed to other public entities, including the Ministry of Finance, the Guardia di Finanza and the State Police, if this is required by law or regulation, or otherwise, if disclosure is necessary for the performance of the institutional functions of such entities.

4. Retention and possible transfer of data

Your personal data will be stored at Opera Universitaria di Trento and will not be transferred to a third country or an international organization. The data you provide shall be kept for the time strictly necessary to ensure access to student welfare benefits and until all legal obligations and/or administrative requirements have been fulfilled. The data may be kept for a longer period if it is necessary for archiving purposes in the public interest, or for scientific, historical research, or statistical purposes. In such case, Opera Universitaria ensures respect for the principle of data minimization pursuant to Article 89, paragraph 1 of the Regulation.

5. Data subject's rights

We remind you that you are entitled to:

- obtain information regarding how your data is processed and any other information provided by Article 15 of the Regulation (commonly referred to as the right of access)
- obtain the rectification of inaccurate personal data concerning you under Article 16 of the Regulation (commonly referred to as the right to rectification)
- obtain a restriction on the processing of personal data concerning you under Article 18 of the Regulation (commonly referred to as the right to restriction of processing)
- object to the processing of your personal data in the cases and manner provided for by Article 21 of the Regulation (commonly referred to as the right to object).

GLOSSARY

ACCOMMODATION

The procedures for access to and revocation of accommodation services are set out in the [Rules and Regulations governing the Use of Opera Universitaria Accommodation Facilities](http://www.operauni.tn.it), which can be found on the website www.operauni.tn.it. These are accepted upon completion of the application for benefits.

ATTESTAZIONE ISEE PER IL DIRITTO ALLO STUDIO UNIVERSITARIO

The certification attesting the Equivalent Financial Situation Indicator (ISEE) to apply for student welfare benefits, issued following the submission of the Dichiarazione Sostitutiva Unica (DSU) containing the personal details, income and asset data of the student's household.

The Attestazione is provided by INPS to the declarant within 10 working days of receiving the Dichiarazione Sostitutiva Unica and contains the wording "si applica alle PRESTAZIONI AGEVOLATE PER IL DIRITTO ALLO STUDIO UNIVERSITARIO", followed by the tax codes of the students requesting the benefits.

CREDITS

University credits (CFU) are a means of measuring the learning activities, as defined by Ministerial Decree no. 509/1999. For each study program, the teaching department in charge at each university assigns a number of credits to the various teaching activities (lectures, practical sessions, internships, seminars, theses, etc.).

DICHIARAZIONE SOSTITUTIVA UNICA

The Dichiarazione Sostitutiva Unica (DSU), referred to in Prime Ministerial Decree no. 159 of December 5th, 2013, as amended, is a document that contains the personal details, income, and asset data of the student's household. This document must be filled out to calculate the ISEE for accessing welfare benefits. The data contained in the DSU are partly self-declared and partly obtained from the Italian Revenue Agency (Agenzia delle Entrate) and INPS. For the self-declared sections, the person filling out the DSU (declarant) assumes responsibility, including under criminal law, for the statements made. The DSU is made up of several modules and sections to be filled out according to the household characteristics and the type of benefit requested; for the Attestazione ISEE for university student benefits, the DSU must be entirely filled out (comprehensive DSU — "DSU integrale"). The scholarships and compensation for paid student



collaborations received in the year 2024 must be declared for ISEE purposes.

ESSE3

Esse3 is the management system used by the University of Trento to record all events relating to a study program.

HOUSEHOLD

The student's household is composed of the persons officially recorded as family members as of the date of submitting the Dichiarazione Sostitutiva Unica, subject to the provisions of Article 3 of Prime Ministerial Decree no. 159 of December 5th 2013.

If parents do not cohabit with the applicant student, the applicant is considered part of their parents' household, unless they are an orphan of both parents, a "care leaver" or both of the following requirements are satisfied:

- a. the student has resided outside the original family's dwelling for at least two years prior to the date of submitting the Dichiarazione Sostitutiva Unica, living in a housing unit not owned by a household member;
- b. the student's income, as an employed worker or similar status, declared in their tax return for at least two years is not less than €9.000 euros per year.

For further information please refer to Article 8 of Prime Ministerial Decree no. 159 of December 5th 2013.

IBAN

The IBAN (International Bank Account Number) is an international code made up as follows:

- 2 letters representing the Country (IT for Italy)
- 2 control figures
- The national BBAN code.

ISEE

ISEE is the Equivalent Financial Situation Indicator, the attestation of which enables access to welfare benefits or utilities under favorable conditions. The ISEE is derived from the ratio of the Financial Situation Indicator (ISE



= absolute value given by the sum of income and 20% of movable and immovable assets owned by household members) to the parameter derived from the equivalence scale shown below, including any established increases.

Equivalence scale:

HOUSEHOLD MEMBERS	PARAMETER
1	1,00
2	1,57
3	2,04
4	2,46
5	2,85

The following increases apply:

- 0,35 for each additional member;
- 0,5 for each member with a moderate or severe disability or non-self-sufficient;
- 0,2 if the household includes three children, 0.35 in case of four children, 0.5 in case of at least five children;
- 0,2 for households with minor children, raised to 0.3 if there is at least one child under three years of age, and both parents or the sole parent have carried out working or business activities for at least six months in the year of the declared income. The increase also applies to households exclusively made up of only one non-working parent and minor children. For the sole purpose of this increase, the non-cohabiting parent, who is not married to the other parent but who has recognized the children, is part of the household, unless the specific cases referred to in Article 7, paragraph 1 of Prime Ministerial Decree no. 159 of December 5th 2013 apply.

To determine the parameter of the equivalence scale, a household member who benefits from ongoing residential social and health benefits or who is a non-relative cohabiting member of the household and is not considered as an independent household, increases the equivalence scale by 1.

The ISEE indicator differs according to the type of benefit requested and is valid from the date of submission of the Dichiarazione Sostitutiva Unica until December 31st. The Attestazione submitted as of January 2026 refers to the income received in the second calendar year prior to the submission of the Dichiarazione Sostitutiva Unica.

For the purpose of calculating the ISEE for university student benefits, specific criteria apply to the definition of the household (see "Household" definition).

Scholarships awarded in the year 2024 must be declared for ISEE purposes as tax-exempt income/assistance payments.

Only the amount of the scholarship received in 2024 in relation to the corresponding parameter of the equivalence scale will be subtracted from the ISEE value. Other tax-exempt income (e.g., remuneration received for student collaborations, mobility supplements, etc...) will not be deducted from the ISEE value.

ISEE CORRENTE

The ISEE corrente can be requested when, although the student already has a valid ordinary ISEE, there is a change in the employment status or an interruption of social security and welfare benefits and allowances that fall outside your total income (as declared for IRPEF purposes) for one or more family members; or, when there is decrease of more than 25% in the overall income capacity of the household. For more details see Article 10 of Legislative Decree no. 147 of September 15th 2017, as amended (Article



28-bis of Decree Law no. 34 of April 30th 2019, converted with amendments by Law 58 of June 28th 2019).

ISEE PARIFICATO

The ISEE parificato is the indicator of the equivalent financial situation of a student's household residing abroad (Article 8, paragraph 5, of Prime Ministerial Decree no. 159 of December 5th, 2013), as identified under the Memorandum of Understanding entered into on June 3rd 2015 between the National Association of Bodies for the Right to University Education (ANDISU) and the Authorized Tax Support Center (CAFs) enrolled in the Register of CAFs for employees who are members of the National Council.

ISPE

ISPE is the Equivalent Asset Indicator that is calculated by dividing the asset indicator ($ISP = \text{total real estate assets} - \text{deductions and exemptions}$) + (total movable assets - deductions and exemptions) of the applicant's household by the equivalence scale coefficient (see "ISEE"). ISPE refers to the movable and immovable assets of the second calendar year preceding the submission of the Dichiarazione Sostitutiva Unica.

NON-COMPLIANT ISEE

Non-compliant ISEE is when INPS identifies any omissions or discrepancies with respect to the declarant's statements. For more details see Article 11, paragraph 5 of Ministerial Decree no. 159 of December 5th 2013 and Article 3 of Decree of November 7th 2014.

PARTICULARLY POOR COUNTRIES

As laid down by Ministerial Decree no. 176 of February 24th 2026, the following countries are considered "particularly poor countries": Afghanistan, Angola, Bangladesh, Benin, Burkina Faso, Burundi, Cambodia, Central African Republic, Chad, Comoros, Democratic People's Republic of Korea, Democratic Republic of the Congo, Djibouti, Eritrea, Ethiopia, Gambia, Guinea, Guinea-Bissau, Haiti, Kiribati, Lao People's Democratic Republic, Lesotho, Liberia, Madagascar, Malawi, Mali, Mauritania, Mozambique, Myanmar, Nepal, Niger, Rwanda, , Senegal, Sierra Leone, Solomon Islands, Somalia, South Sudan, Sudan, Syrian Arab Republic, Tanzania, Timor-Leste, Togo, Tuvalu, Uganda, Yemen, Zambia.

PROVINCIAL STUDENT WELFARE TAX

The term "provincial student welfare tax" means the tax provided for by Article 3, paragraph 20, of Law no. 549 of December 28th 1995 and regulated, for the Autonomous Province of Trento, by Provincial Law no. 1 of January 7th 1997. The tax is due from students enrolling in study programs at the University of Trento, as well as at legally recognized universities, university institutes and higher education university institutes,



with registered offices in the province of Trento and that award legally recognized study qualifications. The amount of the tax for A.Y. 2026-2027 is determined by resolution of the Provincial Government no. 333 of 3 March 2017 and no. 341 of 2 March 2018.

RENTAL AGREEMENT

Rental agreements must be signed and registered with the Italian Inland Revenue in the student's name and be valid for at least 10 months during the a.y. 2026-2027 (between September 2026 and August 2027). A copy of the agreement must contain the registration details and be uploaded to the online procedure in PDF format.

If an agreement or a multi-year agreement is renewed, to prove its validity for the a.y. 2026-2027 it is necessary to submit either a copy of the F23 tax form (or an electronic receipt) proving payment of the registration tax, or documents proving that the "cedolare secca" option has been chosen. Students who have entered into a multi-year agreement choosing the "cedolare secca" option and who have already submitted it to Opera Universitaria, only need to provide a self-certification during the term of the agreement, stating that they are still the tenant of the same accommodation; for this purpose, the "Contract self-statement" form, available in the [Scholarships/Forms](#) section of the website www.operauni.tn.it, must be uploaded to the online application.

S.T.E.M.

A set of the scientific-technological disciplines that comprises the following courses offered at the University of Trento:

- Bachelor's degree programs in: Physics, Computer Science, Industrial Engineering, Computer, Communications and Electronics Engineering, Biomolecular Science and Technology, Mathematics, Civil Engineering, Engineering for the Environment and the Territory;
- single-cycle Master's degrees programs in: Construction Engineering/Architecture;
- Master's degree programs in: Cellular and Molecular Biotechnology, Quantitative and Computational Biology, Physics, Mathematics, Computer Science, Artificial Intelligence Systems, Information and Communications Engineering, Materials Engineering, Mechatronics Engineering, Management and Industrial Systems Engineering, Civil Engineering, Energy Engineering, Engineering for the Environment and the Territory, Environmental Meteorology, Environmental Meteorology and Climate Physics, Data Science, Bioengineering for personalized medicine.

TUITION FEES

Tuition fees for the University of Trento consist of fixed-rate university fees and variable contributions (calculated based on the ISEE) required from



students enrolling in a study program. For information on tuition fees payable to the Conservatory of Music or to other university institutes, please contact the relevant administrative offices.

YEAR OF FIRST ENROLMENT

The term “year of first enrollment” means the enrollment, for the first time, in the first year of a study program attended at any university (or institutes that award academic qualifications), except for students who fulfill the requirements set out in paragraphs a, b or c:

- a) who enrolled for the first time in the Italian university system in a program of the same level as the one they are enrolling in for the a.y. 2026-2027 and have withdrawn from their studies immediately or in any case no later than the end of October;
- b) who enrolled for the first time in the Italian university system in an undergraduate or single-cycle Master’s degrees program in the a.y. 2025-2026; have withdrawn from their studies and intend to enroll for the a.y. 2026-2027 in a program within a different degree class; provided that they have returned any benefits received for the a.y. 2025-2026 and paid any outstanding amounts due to both the University and the Student Welfare Body;
- c) who enrolled for the first time in the Italian university system in an undergraduate or single-cycle Master’s degree program in the a.y. 2020-2021 or in subsequent academic years, have withdrawn from their studies at the end of the first year and enrolled for the next academic year in a program within a different degree class (or, in the case of foreign students, have transferred to a program within a different degree class, without credit transfer); provided that they have returned any benefits received in the previous program and have paid any outstanding amounts due to both the University and the Student Welfare Body.

If the student has benefited from a shorter duration of their studies due to the recognition of previous examinations, the year in which they originally enrolled at the university will be treated as the year of their first enrollment.

Any periods of interruption are not taken into consideration when assessing merit if the student has submitted an application for the “temporary suspension” of studies in specific situations, namely:

- a) the birth of a child (for female students);
- b) serious illness.

Any academic action carried out during the interruption period will automatically deprive the student of their right to such benefits.
